Entries close 5th NOVEMBER 2014 . 2 Refunds will not be made after the tournament closing date. Matches may commence on Friday Evening. 3. All juniors must wear approved eyewear. 4. Players may only enter a maximum of 2 events. 5. All players must check in to tournament control 30 mins prior to the starting time of EACH of their matches. 6. Matches to be conducted in either a swiss / knockout / plate or round robin format (depending on entries.) scoring will be PAR 11. 7. All players are to mark and referee the match following their own and at other times if asked to do so. 8. The tournament director decision is final and they reserve the right to refuse any entry and shall not be required to give any reason. 9. Prizes will only be given out at the formal presentation after the completion of finals. 10. First match times will be available 7th of NOVEMBER from 9 am. Event may be reduced to 1 day depending on enteries.
